

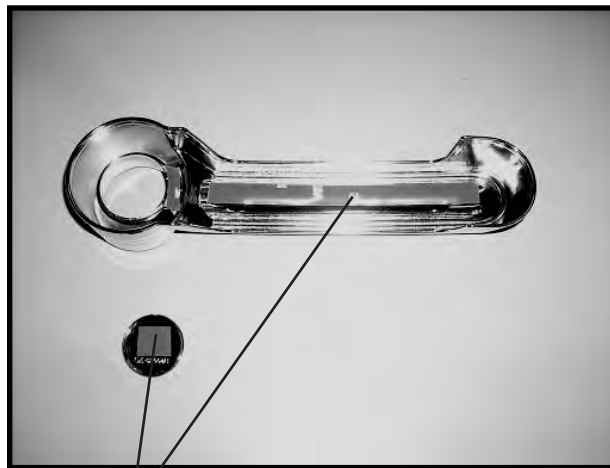
## Chrome Door Handle Overlays

Door Handle Covers  
Door Buttons

1. Installation should be done when temperature is between 65° - 110° F (18°-43° C).  
Clean mounting surface with rubbing alcohol. Avoid areas to which the product will not be adhered. THIS MUST BE DONE FOR ADHESIVE TAPE TO PROPERLY STICK. FAILURE TO CLEAN COULD RESULT IN POOR ATTACHMENT AND FAILURE OF PRODUCT TO STAY ATTACHED. Allow areas to dry completely before attaching door handles.

2. Test fit the Door Handle Cover to the vehicle before removing the plastic backing film. This will aid in aligning the piece properly before securing with the two sided 3M<sup>®</sup> tape. Remove plastic backing film from the affixed two sided 3M<sup>®</sup> tape on the inside of one door handle. The plastic film can be removed easier with the aid of a knife or cutting blade. Peel from leading edges and pull away from tape.

3. Position Door Handle Cover on door handle and apply pressure to secure to vehicle.



4. Remove plastic backing film from the affixed two sided 3M® tape on the inside of one Button Cover. Center the Button Cover on door handle button and apply pressure to secure to vehicle.



5. Repeat steps 1-3 for all door handles.

Note - Do not wash vehicle for 24 hours following installation.
