## **JK Cargo Liner**

## Contents:

Cargo Liner Logo (1 per Cargo Liner) Logo Clips (2 per Cargo Liner)

1. Position the Logo over the oval platform on the Cargo Liner and press it into place, ensuring that the two tabs push through the holes in the Cargo Liner (see Figure 1). Flip the Cargo Liner over. Position the Logo Clips over the tabs and push them into place. To ensure that the logo is secure, use a small socket to push the clips on more tightly (see Figure 2).

2. Your cargo liner will fit Jeep Wrangler JK 4 door, or 2 door with rear seat removed. If your vehicle has a factory sub woofer, trim area A shown in Figure 3. From the bottom of the liner, run a utility knife along the inside edge of the channel molded into the liner (See Figure 4). CAUTION: Always be extra careful when using a utility knife.


